MOTION WAS TABLED UNTIL FEBRUARY 13 MEETING.** VAUGHN EXPLAINED THAT THEY WANT TWP SOLICITOR TO CHECK THE TWP CODE THEY HAVE A PERSON TO PUT ON AND WANT TO VERIFY HOW IT WORKS. THE LAST TIME IT WAS USED WAS IN 1984. TWP IS REQUIRED TO FILL.
