ANNUAL BUDGET REPORT FOR 2015 IS RESOLUTION #4-2014

DISCUSSION: SUPERVISORS/SECRETARY/PUBLIC ----- SECRETARY EXPLAINED THAT SHE DID NOT BUDGET FOR THE FIRE COMPANY SINCE THEY GOT EXEMPT STATUS. DISCUSSED THE ACT 13 MONEY FOR 2015, TWP SHOULD STILL RECEIVE IT SINCE IT IS BASED ON PREVIOUS YEARS ACTIVITY. VAUGHN SAID HE IS ON THE UNDERSTANDING THAT IT SHOULD BE ABOUT 10% LESS THAN WHAT WE RECEIVED THIS YEAR. SECRETARY WILL HAVE TO ADJUST THE AMOUNT FOR THE PROPOSED BUDGET. DISCUSSED THE MONEY CARRIED TO THE BEGINNING OF 2015 COULD BE CHANGED DEPENDING ON THE SPENDING/INCOME OVER OCT TO DEC 2014. SECRETARY STATED SINCE THEY WERE LOOKING INTO DIFFERENT HEALTH INSURANCE, SHE DID NOT BUDGET THE \$5200 FOR THE 3 SUPERVISORS. NOTHING ELSE WAS DISCUSSED. VAUGHN ASKED IF THERE WAS ANY OTHER QUESTIONS ON THE PROPOSED BUDGET.
