REORGANIZATION FOR **SUPERVISORS--**MOTION BY PAUL; 2ND BY VAUGHN; THE REORGANIZATION FOR SUPERVISORS WILL BE ON MONDAY, JAN.6, 2014 AT MUNICIPAL BUILDING AT 7 PM TIME; UNAN-YES(3) THE TWP CODE MANDATES SUPERVISORS MEET ON THE 1ST MONDAY EACH YEAR AND THE AUDITORS ON THE TUESDAY RIGHT AFTER THE 1ST MONDAY. **2. REORGANIZATION FOR AUDITORS** WILL BE ON TUESDAY, JAN. 7, 2014 AT THE MUNICIPAL BUILDING AT 10 AM TIME. TOWNSHIP SECRETARY WILL ADVERTISE THE MEETINGS.

DON HOWARD ASKED HOW WILL OBAMA CARE AFFECT THE FIREMEN? DON SAID THEY ARE TRYING TO MAKE VOLUNTEER FIREMEN'S HEALTH CARE PAID BY THE TWP THEY ARE IN. VAUGHN SAID THEY HAVE TO BE OVER 50 PEOPLE, BUT RIGHT NOW FAIRFIELD IS NOT OVER THE 50, BUT IF THEY REACH THAT, IT COULD BE A PROBLEM. VAUGHN SAID PERSONALLY TWP WILL TALK TO THE FIRE COMPANY ABOUT THE MEMBERSHIP. DON SAID THEY ARE TRYING TO GET A BILL ESTABLISHED NOW TO ELIMINATE THAT. VAUGHN SAID WHAT SCARES HIM IS THAT THIS COULD ENTICE INDIVIDUALS TO JOIN A FIRE COMPANY JUST FOR THE HEALTH INSURANCE. SECRETARY SAID HOW CAN TWP AFFORD THAT, THERE ARE SOME TWPS THAT STILL CAN NOT AFFORD IT FOR THEIR OWN EMPLOYEES. VAUGHN SAID IT WAS IN THE PACKAGE OF OBAMA CARE. SECRETARY SAID OUR TWP IS ALREADY BURDENED BY THE COST OF THE FIRE COMPANIES WORKERS COMP, WHICH INCREASED SUBSTANTIALLY. VAUGHN SAID THEY HAVE TO BE ACTIVE DUTY. DON SAID THEY ARE VOLUNTEERS NOT EMPLOYEES. SECRETARY SAID THEY WORK AT OTHER PLACES. TOM BLON SAID THERE ARE PEOPLE ON WELFARE AND DISABILITY NOW, EVERYONE IS TRYING TO GET ON IT. ALICE WHITE ASKED WHAT NPDES STANDS FOR. PAUL GUESSED NATIONAL POLLUTION DISCHARGE EROSION SEDIMENT. VAUGHN SAID ORCHARD HOLLOW RD IS OFF 259 PAST THE 2 LAKES ALREADY THERE. MAUREEN ASKED IF ANYONE CAN MAKE A LAKE? PAUL AND VAUGHN SAID NO. VAUGHN SAID IT IS EXTREMELY EXPENSIVE. PAUL SAID IT IS THE OLD GINDLESBERGER ROAD.
