V. CORRESPONDENCE: 1. SKELLY & LOY: PUBLIC COMMENT FOR OUTSIDE IN SCHOOL PLANNING MODULE CLOSED 4/15/15—NO COMMENTS RECEIVED. SKELLY AND LOY WERE ENGINEERS INVOLVED WITH THIS PROJECT FOR OUTSIDE IN. GENE GIERNACKY EXPLAINED THAT THEY HAVE A SEWAGE TREATMENT FACILITY ON THE PREMISES. DEP RECOMMENDED THEY PUT IN AN ANALOG SYSTEM WHICH MEANT EVERYTHING IS UNDERGROUND. WHEN GENE CONTACTED THEM TO ENLARGE THE SYSTEM, DEP SUGGESTED AN ANAEROBIC SYSTEM WOULD DIE OUT. CANNOT REPAIR AND DEP WANTED THEM THEN TO PUT IN AN AEROBIC SYSTEM. THEY DID RESEARCH WHICH AEROBIC SYSTEM WOULD BE BEST FOR THIS AREA AND THEY CAME UP WITH THE AEROBIC SYSTEM MANUFACTURED BY DUTCHLAND CORP OUT OF LANCASTER.
