VIII. NEW BUSINESS: 1. 2017 MMO FOR PENSION PLAN PREPARED AND PRESENTED TO THE BOARD OF SUPERVISORS BY SECRETARY; SECRETARY EMMA EXPLAINED THAT THERE IS A PRINTOUT TO SHOW THE 2017 MMO WORKSHEET WHICH HAS TO BE SUBMITTED TO THE PMRS BY SEPT 30TH. MMO STANDS FOR MINIMUM MUNICIPAL OBLIGATION AND IT IS FOR TWP PENSION. PMRS SENDS THE FORM TO US ANNUALLY AND I HAVE TO ESTIMATE THE 2016 W2'S FOR THE PENSION EMPLOYEES AND USE THE TOTAL TO CALCULATE WHAT OUR ESTIMATED 2017 MMO. IT IS ESTIMATED TO BE \$19,728. PMRS GIVES US THE PERCENTAGE OF THE WAGES AND THE COSTS TO ADD TO OUR BILL. THE TOWNSHIP DOES RECEIVE STATE AID FOR THE COST OF THE TWP PENSION. USUALLY VERY LITTLE MONEY IS USED OUT OF THE GENERAL FUND. THE BOARD OF SUPERVISORS HAVE TO APPROVE THE 2017 MMO AT A PUBLIC MEETING. MOT BY PAUL; 2ND BY VAUGHN; TO APPROVE THE 2017 MMO WORKSHEET AS PRESENTED ESTIMATED TO BE \$19,728. CARRIED (V. TANTLINGER-YES/ P. ALTIMUS-YES/ J. BROWN-YES) SOLICITOR ASKED SUPERVISORS IF THEY WANTED HIM TO BRING UP ABOUT ANTIOCHIAN. PAUL SAID NOT AT THIS TIME. VAUGHN ASKED IF HE HAS ANYTHING NEW AT THIS TIME. SOLICITOR SAID NOT AT THIS TIME.

IX. PUBLIC COMMENT: 1. ED SHORT-THANKED THE TOWNSHIP FOR GETTING STARTED ON THE DRAIN PROBLEM. HE REALIZED THEY WENT THRU HIS DRIVEWAY, HE ASKED IF TWP WAS GOING TO BLACKTOP THE EDGE TO THE INLET. ANY MODIFIED CAN THEY PUT BACK IN BECAUSE IT HAS SUNK. PAUL SAID TWP MAY DO A TOP DRESS, TWP WILL NOT BLACKTOP BEFORE OCTOBER SO THAT IT HAS TIME TO SINK. PAUL SAID WANT TO GIVE IT AS MUCH SETTLEMENT TIME AS POSSIBLE. VAUGHN SAID MAYBE CAN GET A TRUCK DOWN TO FILL IT IN SOME. VAUGHN SAID TWP WILL CEMENT COMING DOWN, BOTH WAYS ON IT. PAUL SAID FROM THE HIGH SIDE OF THE INLET BOX, IT IS PROPERTY OWNERS TO MAINTAIN NOW. TWP WILL GET THE PIPE TO BE INSTALLED IN THE REMAINING DRAINAGE AREA AT COST TO PROPERTY OWNER. ED ASKED IF HE HAD TO CEMENT IT ON HIS END, SUPERVISORS SAID IT IS HIS PREFERENCE BECAUSE IT IS HIS FACILITY. ED SAID THEY WERE AT THE LAST 2 MEETINGS AND NO ONE WAS HERE. PAUL SAID THE TIME CHANGES WERE ADVERTISED JANUARY 1ST. PAUL SAID 12" DIAMETER/SOLID FOR 100'. PAUL SAID TWP LIKES BAND FOR FLEXIBILITY. ED SAID GO BANDS. MARK RONEY SAID HE ONLY USED THE SLIDE. PAUL SAID BANDS IT IS. ED SAID TO INVOICE HIM, AND ASKED WHEN TWP WILL HAVE THE PIPE. PAUL SAID MAYBE TOMORROW. PAUL SAID DUE WITHIN 30 DAYS. PAUL ASKED IF HE WAS ABANDONING THE CROSS, ED SAID YES. MARK SUGGESTED TAKING IT OUT. ED SAID HE ISN'T REMOVING BECAUSE YOU WOULD HAVE TO PAVE THE ROAD, AND HE IS NOT DOING THAT. ED SAID THEY WILL FIGURE IT OUT. ED ASKED WHAT ONE OF THOSE INLET BOXES COST, PAUL SAID \$350. PAUL SAID IT WAS NOT AS EASY AS THEY FIGURED, IT IS IN, IT IS DONE. ED ASKED TWP TO GIVE HIM A CALL WHEN THEY PAVE SO HE CAN HAVE HIS CARS OUT OF THE WAY. PAUL SAID GOING TO DO AS LATE AS HE CAN, GOING TO CHECK WITH THE ASPHALT PLANTS. 2. MARK RONEY 3. DAN BRENDLINGER ED ASKED WHAT IS GOING ON AT ANTIOCHIAN? SOLICITOR SAID TWP IS LOOKING INTO POSSIBILITY IN DETERMINING WHETHER THEIR TAX EXEMPTIONS ARE APPROPRIATE. SECRETARY SAID THEY ALSO HAVE LIQUOR LICENSE NOW. VAUGHN SAID WHEN SON HAD HIS RECEPTION AND THEY CHARGED A LOCAL TAX.
