BILL HUGHES ASKED WHY 3 SUPERVISORS HAVE CELL PHONES. PAUL SAID IT WAS TALKED ABOUT FOR SEVERAL MONTHS LAST YEAR & THEY ARE SUPERVISORS 24/7 THEY THOUGHT THEY WOULD MAKE THEIR SELVES AVAILABLE BY HAVING COMMUNICATIONS THAT WAY. BILL SAID THEY HAVE THE OFFICE AND RADIOS IN THE TRUCK., WHY SHOULD TAX PAYERS HAVE TO PAY \$138 A MONTH WHEN YOU RAISED THE TAXES 2 YEARS AGO WHICH ADDED \$20,000 TO THE BUDGET. IS THAT WHY YOU RAISED TAXES TO ADD MORES EXPENSES FOR SUPERVISORS, SO THEY CAN HAVE A CELL PHONE. PAUL SAID NO. BILL ASKED WHY SUPERVISORS CAN'T BUY THE PLAN THEMSELVES. PAUL STATED BEING SUPERVISORS 24/7 THEY HAVE TO MAKE THEMSELVES AVAILABLE FOR EMERGENCY SITUATIONS, ETC.; FOR TIMES NOT AT HOME, NOT AT TWP BUILDING, OR IN TRUCKS. DO EACH SUPERVISOR LOOK AT EACH OTHERS CELL, DOES EMMA LOOK TO MAKE SURE THEY ARE ALL COMPANY CALLS OR ARE THEY PERSONAL CALLS; OR DID YOU SET UP STIPULATION WHERE YOU CAN USE FOR PERSONAL CALLS. SOLICITOR ASKED IF THEY ALLOW ENGINEER FEES IN THE GRANT MONEY. PAUL SAID THE GRANT MONEY IS SPECIFICALLY FOR THE CONSTRUCTION NOT THE ENGINEERING FIRM. 3. MIKE BARTLEY-SAID IF SCOTT COULD PUT ALL THESE THINGS IN WRITING, AND AS EMC SOME OF COMMENTS RELATED TO WHAT THEY DO, MAYBE THEY COULD PROVIDE SOME ANSWERS IN WRITING. SCOTT SAID HE DOES NOT ANSWERS IN WRITING. SOLICITOR SAID IT MAY NOT ADDRESS EVERYTHING, BUT YOU MAY HAVE SUGGESTIONS. SCOTT IS MORE THAN WILLING TO DO WHATEVER NECESSARY TO HELP THE SUPERVISORS, HE IS SINCERE.
