**VII. OLD BUSINESS: 1. FINAL ADOPT 2012 BUDGET** - **RES#5-2011 TAX LEVY RESOLUTION** AT 3.1 MILLS. TWP RECEIVED NOTICE OF NEW AMOUNT FOR POPULATION OF **2010 CENSUS OF 2424**. THERE WAS A DECREASE OF \$2,550; THEREFORE THE BUDGET HAD TO BE CORRECTED SHOWING THE INCOME/EXPENSE CHANGES. STATE FUND DROPPED FROM \$207,000 TO \$204,450. THE TOTAL BUDGET SUMMARY THEN CHANGES FROM \$560,208 TO \$557,658

**VIII. NEW BUSINESS: 1. SUPERVISORS REORG MEETING;** MOTION BY VAUGHN, 2<sup>ND</sup> BY PAUL TO HOLD REORGANIZATION MEETING ON **TUESDAY, JAN. 3, 2012** AT MUNICIPAL BLDG AT 7:00 PM. AUDITORS MUST MEET THE FOLLOWING DAY, IN CHECKING WITH THEM TO WHAT TIME, THEY ARE GOING TO MEET AT THE MUNICIPAL BUILDING ON **WEDNESDAY, JAN. 4, 2012** AT 11:30 AT THE MUNICIPAL BLDG. UNAN-YES(3) SECRETARY WILL ADVERTISE. VAUGHN SAID REGINA WILL BE OUT OF TOWN. LAURA SAID THEY WILL BE IN A TELECONFERENCE IF THEY NEED REGINA, BUT SHE DOES NOT SEE MUCH CHANGING. PAUL SAID DON'T BE SURPRISED.

2. BERKHEIMER – WAS APPOINTED AT OUR LAST MEETING TO COLLECT ACT 511 TAXES(LST/OPT—PER CAPITA—AMUSEMENT). PAMS WILL NO LONGER COLLECT ANY TAXES FROM JAN 1, 2012. PAMS WILL CONTINUE TO COLLECT ALL DELINGUENT AND CURRENT TAXES UP TO DEC 31, 2011. BERKHEIMER HAS SENT US RESOLUTIONS AND AGREEMENTS FOR COLLECTION OF THOSE TAXES. THEY ARE AS FOLLOWS:

C. RES#7-2011 CONFIDENTIALITY WHICH APPOINTS A LIASON BETWEEN BERKHEIMER AND THE TWP, WHO WILL BE ABLE TO SHARE INFORMATION. SECRETARY ASKED IF THEY WOULD BE APPOINTING HER, PAUL SAID IT IS NOT AN APPOINTMENT, IT IS JUST DESIGNATING IT IN THE RESOLUTION--IT IS NOT A TRUE APPOINTMENT. SOLICITOR SAID IT IS NOT A NEW OFFICE. PAUL SAID WE DO NOT HAVE TO SPECIFICALLY STOP AND RECOGNIZE HER BECAUSE THE RESOLUTION DOES THAT. SOLICITOR SAID CORRECT. PAUL SAID OR DON'T YOU WANT TO BE? SECRETARY SAID SHE REALLY DOES NOT KNOW WHAT HE MEANS, IT ONLY MEANS THAT SHE CAN TALK TO THEM ABOUT THE TAXES. SECRETARY WAS GOING TO ASK SOLICITOR IF THE APPOINTMENT COULD GO BY POSITION INSTEAD OF A SPECIFIC PERSONS NAME, SUCH AS SECRETARY AND OR CHAIRMAN; LIKE TWP DID FOR THE PENSION PLAN. SOLICITOR SAID YES AS LONG AS BERKHEIMER DOES NOT HAVE A PROBLEM WITH THAT. MOT BY PAUL, 2<sup>ND</sup> BY JIM, TO ADOPT RES#7-2011 NAMING EITHER EMMA BRENDLINGER OR JUST NAMING THE POSITION SUCH AS SECRETARY AND CHAIRMAN; UNAN-YES(3)

**G. RES#11-2011 AMUSEMENT TAX & AGREEMENT** AGAIN WITH THE RULES/DUTIES/REGULATIONS FOR THEM TO COLLECT THE AMUSEMENT TAX. MOT BY JIM, 2<sup>ND</sup> BY VAUGHN; TO APPROVE RES#11-2011 AMUSEMENT TAX AND AGREEMENT; UN-YES (3) PAUL SAID AMUSEMENT TAX WILL BE NEW TO PEOPLE, SECRETARY SAID IT WILL BE UP TO BERKHEIMER TO DECIDE WHO SHOULD PAY THIS. SECRTARY THINKS IT IS FOR ANYTHING THAT THERE IS A FEE FOR ADMISSION—SUCH AS GOLF COURSE, MIRROR LAKE AND WHAT ABOUT ANTIOCHIAN VILLAGE NOW? FAIRFIELD FIRE HALL FUND RES#13-2011**—FAIRFIELD FIRE COMPANY WANTS TWP TO KEEP THE FIRE COMPANY FUND OPEN FOR ANOTHER YEAR. MOT BY PAUL, 2<sup>ND</sup> BY VAUGHN TO APPROVE KEEPING THE FIRE COMPANY FUND ACCOUNT OPEN FOR 2012, UN-YES(3) **4.
