SECRETARY WILL ADVERTISE THE FINAL ADOPTION, BUDGET WILL BE OPEN FOR PUBLIC INSPECTION DURING NORMAL BUSINESS HOURS.

SUBDIVISION FOR PATRICIA LENTZ ESTATE PLAN**; DISCUSSION: PAUL EXPLAINED THAT IT WAS PARCEL THAT CONSISTS OF 95 ACRES, THE PARENTS ARE BURIED ON THE LAND. CARL FULCOMER—ASKED IF REORGANIZATION MEETINGS ARE OPEN TO THE PUBLIC, VAUGHN SAID PUBLIC. HE ASKED WHEN THEY DO TRAFFIC SURVEYS ON ROADS—LIKE HYPOCRITE THIS PAST SUMMER; WAS THAT TO CHECK TRAFFIC ON BRIDGES OR ROAD? PAUL SAID IT WAS PENDOT, TWP HAS NO IDEA. CARL ASKED IF TWP IS INFORMED OF THE OUTCOME. PAUL SAID SOMEONE COULD PROBABLY OBTAIN THE INFORMATION. CARL WANTS TO KNOW THE COMPARISON OF THE LAST COUNT WITH THE ONE THEY DID MAYBE A FEW YEARS AGO. CARL JUST WANTS TO KNOW WHAT THE INCREASE IS, AND HOW DO YOU GET A NEW ONE DONE WITH THE CURRENT TRAFFIC. HE ASKED IF EACH BOND IS WRITTEN UP INDIVIDUALLY. PAUL SAID EVERYTHING IS THE SAME EXCEPT FOR THE COST. CARL ASKED ABOUT WHAT TWP IS DOING WITH THEM PACKING DOWN THE SNOW AND MAKING THE ROADS ICY. PAUL SAID WE ARE SUBMITTING THEM INVOICE FOR ANTI SKID COSTS. CARL ASKED ABOUT SALT. VAUGHN SAID TWP DOES NOT USE SALT. PAUL EXPLAINED THAT IT IS NOT TWP DOES NOT LIKE TO USE SALT, WE JUST CAN NOT AFFORD TO FIX WHAT IT DOES TO THE ROADS. CARL WANTS THE COUNTS FROM PENDOT. CARL ASKED WHAT IS GOING ON WITH THE PIPELINE CROSSING HYPOCRITE TO HENDERSON'S. PAUL SAID IT IS SCHEDULED TO BE BORED, BUT HE THINKS BORING MACHINE IS ON ECKEL'S SITE, THEY ARE BORING UP OVER HILL TO GET BACK ON TOP. PAUL SAID THEY GOT TO GET UNDER HYPOCRITE AND BACK ON TOP TO HAZE'S. VAUGHN SAID PENDOT WILL NOT LET THEM BORE UNDER THEIR ROADS OVER 200 DAYS. **8. DAN BRENDLINGER 9.
