V. CORRESPONDENCE: 1. LANE GARLAND RESIGNATION-- ACCEPT RESIGNATION OF TCSA; HIS TERM EXPIRED JAN 1, 2013; MOTION BY JIM TO ACCEPT LANE GARLAND'S RESIGNATION FROM THE TCSA; 2<sup>ND</sup> BY VAUGHN, UN-YES(3) VAUGHN SAID THERE WAS SOMEONE THAT HAD SHOWN AN INTEREST IN THE POSITION. VAUGHN ASKED IF TWP SHOULD CHECK TO SEE IF SHE IS STILL INTERESTED. SECRETARY REMINDED THE BOARD THAT RICH GARLAND ALSO SUBMITTED A LETTER OF INTEREST IN SERVING ON THE TCSA BOARD. VAUGHN SAID TWP WILL HAVE TO SEE WHO IS INTERESTED IN THE VACANCY. 2. GAS WELL NOTICES – WEST WHEATFIELD AND DERRY.

VI. PERSONS PLACED ON AGENDA: 1. CAROL - NO SHOW. 2. BONNIE LONG-NOT ABLE TO MAKE IT

VII. OLD BUSINESS: LTMA UPDATE FROM BEN FAAS. PLANNING THIS PROJECT FOR 2 YRS. THE DID RECEIVE FUNDING—ALL LOAN. DURING WHICH LTMA PAID OFF A BOND ISSUE WHICH FREED UP A \$200,000 ANNUALLY IN DEBT SERVICE. THE PROJECT WAS PLANNING TO USE THAT DEBT SERVICE. NUMBERS HAVE NOT CHANGED, HOWEVER WHEN THE FUNDING CAME THRU LTMA HAS HAD SOME SEWER PROJECTS AND LINE BREAKS; AND THE EXISTING SYSTEM HAS OVER 50 MILES OF LINE IS OVER 60 YRS OLD AND CONSTRUCTED OF ASBESTOS CEMENT PIPE AND IT HAS NOT WITHSTOOD THE TEST OF TIME. THEY HAVE BEEN DEALING WITH THE BREAKS, AND THIS AGING PROJECT TO THE FRONT. SO WHEN FUNDING CAME THRU, THEY STARTED THINKING OF THE 20 YR DEBT SERVICE THEY WOULD BE COMMITTING TO AND IN THOSE 20 YRS THEY WOULD HAVE TO HOPE THE EXISTING LINES HELD TOGETHER. OTHERWISE IT WOULD REQUIRE RATE INCREASES TO EXISTING AND NEW CUSTOMERS. BECAUSE OF THIS, THEY DID NOT ACCEPT PENVESTS OFFER. THEY ARE CONTINUING TO PURSUE ALTERNATE FUNDING TO MAKE THE PROJECT ACCEPTABLE TO THEM. HE IS NOT VERY HOPEFUL THAT LEVEL OF FUNDING TO GO THRU. THIS PROJECT IS SHOVEL READY WITH PERMITS, SO THEY WILL CONTINUE TO EXTEND PERMITS AS LONG AS DEP ALLOWS. HE IS HOPING FOR SOME KIND OF FUNDING TO POTENTIALLY PROCEED. AS FOR NOT CONTINUING WITH THE PROJECT. PAUL SAID TWP NEEDED INFORMATION ON WHAT WAS GOING ON, BECAUSE LTMA HAS NOT SAID ANYTHING TO US REGARDING WHERE THIS PROJECT STOOD. BEN APOLOGIZED. VAUGHN ASKED SOLICITOR ABOUT THE ORDINANCE. SOLICITOR SAID TO SIT AND WAIT FOR A BIT TO SEE WHAT HAPPENS.
