PAUL MADE MOTION TO TABLE BIDS UNTIL REVIEWING THEIR INFORMATION. JEFF SAID THEY HAD TO EITHER REJECT OR ACCEPT BIDS. PAUL SAID TWP TABLED LAST YEAR. PAUL MADE MOTION TO ACCEPT HANSON AGGREGATE BID FOR CONTRACT B, 2<sup>ND</sup> BY VAUGHN, UNAN—2 YES. JEFF SAID ABOUT ADVERTISING THEM AS SEPARATE ITEMS. PAUL ANNOUNCED TWP HAS ALWAYS ADVERTISED AS A WHOLE. CONSIDER BIDDING ANTI-SKID SEPARATE NEXT YEAR. BOB GRAHAM SUGGESTED LETTING THE MOTION DIE FOR LACK OF 2<sup>ND</sup>, TABLE IT AND GO TO SPECIAL MEETING. JEFF SAID WOULD BE OKAY FOR JUST THESE BIDS, BUT CAN NOT LOOK AT THE COG BIDS. VAUGHN MADE MOTION TO ACCEPT NEW ENTERPRISE BIDS FOR CONTRACT A, 2<sup>ND</sup> BY PAUL, UNAN—2 YES.

2. CERTIFIED LETTER TO DEP WAS SENT 2/21/08 REQUESTING A PUBLIC MEETING FOR THE COAL BED METHANE TO BE HELD IN THE EVENING. LETTER WAS SENT TO TOM FLAHERTY, PA DEP, BUREAU OF OIL & GAS, PITTSBURGH, PA. IT WAS RECEIVED BY DEP, BUT TWP HAS NO RESPONSE AT THIS TIME FROM DEP. 3. AT LAST MEETING IT WAS SUGGESTED SAMPLE ORDINANCES BE OBTAINED—ONE FOR NOISE AND ONE FOR WIND ENERGY; THE SOLICITOR HAS DRAFTED THESE ORDINANCES AND GAVE IT TO THE TWP ON MONDAY—ANYONE WANTING TO REVIEW THEM BEFORE ADOPTION MAY DO SO. JEFF GAVE UPDATE ON COAL BED METHANE—1<sup>ST</sup> DID PREPARE A LETTER REQUESTING A HEARING, ALSO SPOKE TO JOSH WETZEL ON BOARD OF LOYALHANNA WATERSHED ASSOC. HE PROMISED TO PUT TWP IN TOUCH WITH AN ATTORNEY WHO SPECIALIZES IN ENVIRONMENTAL LAW THAT THE TWP COULD CONSULT WITH. HE DID GIVE HIM NAME OF STAN STEIN AND JEFF DID TALK TO HIM—HE IS WITH FIRM IN PITTSBURGH. STEIN SITS ON A THE BOARD OF LOYALHANNA WATERSHED ASSOC. WITH MR. WETZEL. HE HAS INDICATED THAT HE IS WILLING TO TALK TO US AT NO COST TO GIVE OUTLOOK ON DEP PROCEDURES. JEFF ALSO SENT HIM THE INFORMATION HE HAD AND MAYBE FROM THAT INFORMATION HE COULD GIVE TWP SOME INFORMATION REGARDING THIS PARTICULAR DRILLING SITUATION. HE WILL PROVIDE JEFF WITH A DATE WHEN HE CAN COME UP AND TALK TO THE SUPERVISORS AND PUBLIC. JEFF ALSO TALKED TO BEN WRIGHT-FROM WESTMORELAND CONSERVANCY AND HE GAVE HIM JIM CASTLEBURY'S INFORMATION—HE IS AN HYDROLOGIST FROM PENN STATE. JEFF CALLED AND LEFT A MESSAGE, AND IT IS JEFF'S UNDERSTANDING FROM MR. WETZEL—HE MAY BE A BOARD MEMBER FOR PENNS FUTURE, AND PENNS FUTURE HAS RETAINED CASTLEBURY AND THEY ARE IN THE PROCESS OF THEY ARE IN THE PROCESS OF DOING THESE VARIOUS STUDIES. JEFF LET THEM KNOW THE TWP IS INTERESTED IN THEIR WORK. JEFF SAID THE NOISE ORDINANCE THAT BARRY TUSCANO SUGGESTED DOES NOT DEAL SPECIFICALLY WITH DRILLING, IT DEALS WITH ALL NOISES AND THAT IS WHAT THE TWP HAS TO DO IF TWP IS GOING

TO ADOPT A NOISE ORDINANCE, BUT IT DOES HAVE PROVISIONS THAT WOULD LIMIT THE HOURS AND THE DECIMAL LEVELS THAT CARRY OFF THE PROPERTY.

VIII. NEW BUSINESS: 1. PAUL STATED THAT THE CONSUMPTION OF DIESEL FUEL HAS RISEN AND HAS EXCEEDED THE \$10,000 LIMIT, BY 2N CLASS TWP CODE ANYTHING OVER \$10,000 HAS TO BE BID. OUR PENDOT REPRESENTATIVE SAID OTHER TWPS AND BOROUGHS ARE DOING IT. PAUL MADE A MOTION TO ADVERTISE FOR DIESEL TO BE OPENED AT THE APRIL 10<sup>TH</sup> MEETING, 2<sup>ND</sup> BY VAUGHN, UNAN—2 YES. JEFF THINKS IF YOU BID ONCE AND DO NOT GET BIDS, YOU MAY NOT HAVE TO REBID, YOU MAY THEN GO TO TELEPHONIC QUOTES. 2. WESTMORELAND COUNTY CONVENTION WILL BE HELD ON FRIDAY, MARCH 14, 2008 AT FOUR PTS HOTEL IN GREENSBURG, REGISTRATION IS 8:30 AM AND WILL END AROUND 4 PM. MOTION BY PAUL, 2<sup>ND</sup> BY VAUGHN TO PERMIT ANYONE WISHING TO ATTEND THAT IS ELIGIBLE, MAY ATTEND WITH WAGES OR CONVENTION FEE PLUS MILEAGE BEING PAID; UNAN—2 YES. 3. QUAKER SALES GAVE US A DOWNSTREAM NOTIFICATION OF ASPHALT MATERIALS.

ASKED SUPERVISORS TO LOOK INTO ANY RECOMMENDATION THEY MAY MAKE. 8. BOB MALNOSKY COMPLIMENTED SECRETARY ON THE MINUTES, THAT SHE WAS DOING A GREAT JOB. AND HE APOLOGIZED TO THE SOLICITOR REGARDING THE TRACKS ARE NOT ON NEIPORTS PROPERTY, SOLICITOR WAS RIGHT. KURT LIMBAUGH WENT TO THE WATERSHED MEETING AT WCCC, PENNS FUTURE HAS 2 LAWYERS THAT IS GOING TO GO TO THE MEETING WITH DEP IF WE ARE SUCCESSFUL IN GETTING THE MEETING SET UP. 9. KAREN BORING WANTED TO KNOW TWPS PLANS ON FIXING STIFFLER ROAD. PAUL SAID THE TWP SAY THE WATER DAMAGE ON IT AND WILL BE AROUND. 10. DEB GAWLAS PENN FUTURE IS GOING TO REPRESENT US, THE ATTORNEYS ARE KURT WEIST FROM HARRISBURG AND JOHN BAILEY FROM PITTSBURGH; AND THEY WILL PROVIDE LEGAL COUNSEL. THEY ALSO HAVE SENT A LETTER TO DEP, BUT HAS NOT RECEIVED A REPLY YET. THERE IS ALSO HOUSE BILL 1735 THAT CAME OUT, BUT IT DOES NOT HAVE ENOUGH STRONG POINTS TO PROTECT THE LANDOWNER—THEY ARE GOING TO MAKE RECOMMENDATIONS ON THE BILL. SHE ASKED SUPERVISORS ABOUT THE WATER ORDINANCE? ANY CONSIDERATION? JEFF SAID THEY LOOKED AT SAMPLE OF COMPREHENSIVE PLAN FOR MANAGEMENT, AND AT THIS POINT THE BOARD HAS NOT GIVEN ANY CONSIDERATION TO ADOPTING ONE AT THIS TIME, AND THIS SAMPLE CAME OUT OF A WATERSHED AREA AND SOME OF THE IDEAS IN THE PLAN WERE THINGS LIKE STORM WATER MANAGEMENT.
