**VII. OLD BUSINESS:** 1. SOLICITOR HOP INDEMNIFICATION THE TWP HAS WITH JOHNSTOWN WATER COMPANY, VAUGHN HAD ASKED HIM TO CHECK THE STATUS. THEY HAVE APPROVED AND SIGNED IT, BUT SORT OF GOT STUCK WITH BRUCE GRAHAM—SO THEY, MEANING GIBSON THOMAS, WILL HAVE IT HERE IN HAND WITHIN A FEW DAYS. PAUL SAID THIS IS TO BE FUNDED BY WESTMORELAND WATER, INCLUDING TWP SOLICITORS TIME AND COST. SOLICITOR SAID YES, BY AGREEING TO THE TERMS OF THE INDEMNIFICATION AGREEMENT.

UN-YES (3) PAUL STATED TWP HAS TO SET THE TIME FOR TREATING WITH OUR TWP, THE OTHERS ARE JUST MENTIONED BECAUSE WE TRY TO COORDINATE WITH THEM. 2. BUDGET WORKSHOP VAUGHN SAID SUPERVISORS MEET FOR WORKSHOP, NOVEMBER TENTATIVELY ADOPT, FINAL AT DECEMBER REGULAR MEETING. PAUL SAID TO HAVE IT NOV 1<sup>ST</sup> AT 7 PM. VAUGHN THOUGHT WE DID IT AT 3 PM RIGHT AFTER WORK. PAUL SAID HE THOUGHT LATER FOR THE PUBLIC. VAUGHN SUGGESTED 6 PM, JIM STILL WANTS AT 3 PM. SECRETARY STATED THAT NO ONE USUALLY COMES TO OUR BUDGET WS MEETING. ALICE WHITE ASKED IF IT WAS OPEN TO THE PUBLIC WHEN WORKING ON THE BUDGET. SUPERVISORS SAID YES. MOTION BY VAUGHN, TO ADVERTISE BUDGET WS FOR NOV. 1ST AT 6 PM AT THE MUNICIPAL BUILDING AND IT IS OPEN TO THE PUBLIC, 2<sup>ND</sup> BY PAUL; UN-2 YES (VT/PA) 1 NO (JB); MOTION CARRIED. 3. FOREIGN FIRE MONEY-WAS DIRECT DEPOSIT IN GF ON 9/21/2012 IN THE AMOUNT OF \$13,707.75. THIS MONEY IS BASED ON 50% POPULATION AND 50% ON MARKET VALUE OF THE REAL ESTATE FOR VOLUNTEER FIRE COMPANIES. RES #7-1988 STATES THAT FAIRFIELD V.F.C. RECEIVES 85% (\$11,651.59) AND BOLIVAR V.F.C. RECEIVES 15% (\$2056.16). MOTION BY PAUL, 2<sup>ND</sup> BY VAUGHN, TO DISTRIBUTE THE FOREIGN FIRE MONEY AS OUTLINED IN RESOLUTION #7-1988; UN-YES (3) MAUREEN ASKED WHY IT IS CALLED FOREIGN MONEY. PAUL FEELS IT IS BECAUSE IT COMES FROM OUTSIDE THE TWP. SOLICITOR BELIEVES THE MONEY COMES FROM SURCHARGES ON INSURANCE POLICIES, AND IT IS THE STATUTORY TERM. 5. STATE AID FOR TWP PENSION FUND HAS BEEN DEPOSITED IN THE GENERAL FUND IN THE AMOUNT OF \$10,056.11 ON 9/21/2012; IT IS TO BE SENT TO PMRS WITH \$1921.89 FROM THE GENERAL FUND ACCOUNT. SOLICITOR SAID WHEN THE TWP SETS DOWN TO DO THE BUDGET, REMEMBER THAT THE WC WILL HAVE A SUBSTANTIAL INCREASE. PAUL SAID HE HAS THE INSURANCE AGENT COMING IN NEXT THURSDAY. SOLICITOR SAID THIS TWP WILL BE GETTING IT FROM 2 FIRE COMPANIES. PAUL ASKED WHO WAS THE WC FOR BOLIVAR BOROUGH. SOLICITOR SAID IT HAD BEEN RECHINI. SOLICITOR SAID PROBABLY WC WILL DOUBLE. SOMEONE SUGGESTED JUST GETTING A WC FOR FIRE COMPANY SEPARATE FROM TWP INSURANCE. SOLICITOR SAID ONLY WAY TWP WILL GET ANY RELIEF FROM THE NEW COSTS IS IF THERE IS FUNDING FROM THE STATE.

JIM ANNOUNCED THAT HIS SON, JOSH, JUST GOT BACK FROM KIRGIZSTAN. HE IS STATIONED IN FLORIDA NOW.
