V. CORRESPONDENCE: 1. PAUL WOULD LIKE TO MAKE MENTION THAT FOR THOSE HERE WHO USUALLY VOTE AT THE FAIRFIELD FIRE HALL—THE PRELIMINARY LOCATION WILL BE AT THE TOWNSHIP BUILDING IN THE MEETING ROOM COME NOV. 3RD.

VII. OLD BUSINESS: 1. HIRSCH BRIDGE UPDATE—PAUL ANNOUNCED THAT THE REPAIR PROCEDURE IS IN THE HANDS OF PENDOT AND STILL WAITING ON THE APPROVAL FROM DEP FOR THE STREAM ENCROACHMENT. TWP WAITING ON SOMEONE TO REPLY BACK TO US.

VIII. NEW BUSINESS: 1.FOREIGN FIRE MONEY HAS BEEN RECEIVED AND DEPOSITED--\$14,449.36. THIS MONEY IS BASED ON 50% POPULATION AND 50% ON MARKET VALUE OF THE REAL ESTATE FOR VOLUNTEER FIRE COMPANIES. RESOLUTION #7-1988 STATES THAT FAIRFIELD V.F.C. RECEIVES 85% (\$12,281.96) AND BOLIVAR V.F.C. RECEIVES 15% (\$2167.40) OF THIS MONEY. PAUL MADE A MOTION TO DISTRIBUTE THE FOREIGN FIRE MONEY AS STIPULATED ON RESOLUTION #7-1988; 2^{ND} BY JIM, UNAN—YES. 2. BUDGET WORKSHOP—PAUL ANNOUNCED THIS IS AN ANNUAL WORK SHOP TO GO OVER INCOME AND EXPENSES AND IT IS USUALLY SET FOR A WEEK AHEAD OF THE REGULAR MEETING. VAUGHN MADE A MOTION TO HAVE BUDGET WORKSHOP ON THURSDAY, NOV. 5, 2009 AT 3 PM AT THE MUNICIPAL BUILDING, 2ND BY PAUL, UNAN--YES **3. TRICK OR TREAT**—PAUL ANNOUNCED THAT IT IS SUPERVISORS PLACE TO SET THE DATE AND TIME OF TRICK OR TREATING IN FAIRFIELD TWP. BVFC ANNUAL PARADE IS SET FOR OCT. 25TH AT 2 PM AND BOLIVAR TREATING IS SAME DAY FROM 4-6 PM, WEST WHEATFIELD USUALLY SETS THEIRS FOR THE SAME DAY AS THE PARADE. MOTION BY PAUL FOR TRICK/TREATING TO BE OCTOBER 25^{TH} FROM 4—6 PM, 2ND BY VAUGHN, UNAN—YES. **4. ORDINANCE #3-2009** FOR PARTICIPATION IN THE SOUTH HILLS AREA COUNCIL OF GOVERNMENTS (SHACOG). TWP HAS BEEN LOOKING INTO IT FOR ABOUT 1 YEAR. AND IN GETTING SOLICITOR INVOLVED, IT CAME TO THEIR ATTENTION THAT THIS MAY NOT BE THE RIGHT THING TO DO—HE IS GOING TO BRIEFLY EXPLAIN. SOLICITOR SAID THE COG--TO BECOME INVOLVED IN THE PURCHASED IT IS INTERGOVERNMENTAL COOPERATION, AND IT IS PERMITTED AND ENCOURAGED, BUT ONLY BY AN ORDINANCE. SOLICITOR WENT TO THEIR WEBSITE AND SPOKE WITH THEIR EXECUTIVE DIRECTOR. IT IS A WELL ORGANIZED COG, IN ORDER TO BECOME AN ACTUAL MEMBER IT IS HIS UNDERSTANDING THAT YOU WILL ADOPT AN ORDINANCE—BUT IN ADDITION YOU WILL END UP WITH A VOTING DELEGATE, SOMEONE IS GOING TO BE DOWN THERE TO CONDUCT BUSINESS ON BEHALF OF THE TOWNSHIP. HE THINKS IT IS IN THE SOUTH HILLS AREA OF PITTSBURGH. TWP REALLY WANTS TO MAKE SURE THIS IS SOMETHING THEY WANT TO GET INTO. TWP WAS ON UNDERSTANDING THEY JUST HAD TO DO BY RESOLUTION AND THEN WHEN SHACOG PUT OUT THE BIDS, THE TWP THEN JUST PURCHASES THRU THEIR BIDS. SOLICITOR'S ADVICE IS THAT IS NOT ACCURATE, TWP WILL HAVE TO DO BY ORDINANCE AND THEN FOLLOW THE BY-LAWS FOR THAT COG. VAUGHN SAID THE INDIANA WESTMORELAND COG THAT THE TWP BELONGS TO, RECOMMENDS THAT WE GO, BUT IT IS NOT MANDATORY. SOLICITOR SAID IT MIGHT BE THE SAME, BUT THE TWP HAS A VOTING DELEGATE THAT NEVER SHOWS UP, SO THINK OF IT ALONG THE SAME LINES AS THE TRI COMMUNITY SEWAGE AUTHORITY. PAUL SAID HE THINKS THE TWP NEEDS TO DO MORE HOMEWORK, VAUGHN SAID IF IT TURNS OUT THAT THE TWP DOES NOT HAVE TO MAKE THE TRIP FOR A VOTING DELEGATE IT WOULD BE OKAY. SOLICITOR SAID HE ALSO UNDERSTANDS— THEY HAVE 17 MUNICIPALITIES, NOT 117; AND HE THINKS THEY ARE JOINING WITH OTHER COGS REPRESENTING 117 MUNICIPALITIES. PAUL SAID SUPERVISORS WILL TABLE UNTIL MORE INFORMATION IS GATHERED. 5. VAUGHN ANNOUNCED THAT THE TWP BUILDING WILL BE THE TEMPORARY MEETING PLACE FOR THE FAIRFIELD TWP VOLUNTEER FIRE COMPANY. THEY MET AT THE TWP BUILDING LAST NIGHT. TWP IS ALSO LOOKING INTO WORKING SOMETHING OUT FOR FINANCIAL ARRANGEMENTS. TWP IS TRYING TO WORK WITH THE FIRE COMPANY. SOLICITOR SAID HE THOUGHT MR. FLICKINGER SENT A COPY OF THE RESOLUTION. SECRETARY WENT TO CHECK THE EMAIL, FLICKINGER WANTED IT ACTED ON TONIGHT. VAUGHN SAID IF IT IS OKAY, THEN IT DOES NEED ACTED ON TONIGHT BECAUSE THEY HAVE BEEN APPROACHED BY PEOPLE THAT WANT TO MAKE A DONATION BUT NEED THE TAX EXEMPT STATUS, BASICALLY FOR TAX WRITE OFF OR REPORTING. SECRETARY SAID FLICKINGER SENT AN EMAIL, BUT THERE WAS NO ATTACHMENT OF THE RESOLUTION. PAUL SAID THE TWP WILL DEAL WITH THIS ON A DAY TO DAY BASIS. SECRETARY SAID THE TWP DOES NOT HAVE TO ADVERTISE THE RESOLUTION.

IX PUBLIC COMMENT: 1. ANN MARIE BLON 2. MAUREEN BLON 3. DEB GAWLAS-HILL LOOKS NICE. PAUL SAID IT IS NOT DONE YET. DEB SAID SHE WILL BE ATTENDING THE MEETING ON OCT. 21ST, SHE ASKED IF THERE WAS SOME INFORMATION THAT SHE SHOULD ACQUIRE? SOLICITOR SAID IT WILL BE A

DEB SAID THE HB 1500 AND HB963 IS STILL SITTING IN COMMITTEE. 4. DAN BRENDLINGER 5. KAREN BORING-DID A WONDERFUL JOB ON STIFFLER. PAUL SAID IT WILL BE DUE FOR A 24 HR CLOSURE AGAIN.
