**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF
FAIRFIELD, WESTMORELAND COUNTY, COMMONWEALTH OF
PENNSYLVANIA, PROVIDING FOR AUDITOR COMPENSATION**

WHEREAS, the General Assembly of the Commonwealth of Pennsylvania has enacted Act 10 of 2024, setting forth certain guidelines and limitations for the compensation of auditors of townships of the second class, and;

WHEREAS, the General Assembly by Act 10 authorizes the Board of Supervisors, by Resolution, to determine the compensation of auditors subject to the limitations set forth in the act; and

NOW, THEREFORE, be it resolved that each auditor of the Township of Fairfield entering office after the effective date of this Resolution shall receive compensation for each hour necessarily employed in the duties as a Township Auditor as outlined in Section 901 of the Second Class Township Code in the amount of EIGHTEEN (\$18.00) DOLLARS per hour for actual services rendered.

Pursuant to Act 10 of 2024, auditors in Townships with a population of 10,000 or less, may not receive more than ONE THOUSAND EIGHT HUNDRED (\$1,800.00) DOLLARS for completing the annual audit, settlement and adjustment, for actual services rendered.

In addition, each auditor may receive no more than the amount resolved above per hour for not more than fifty hours to audit the accounts of any public official who handles public funds when a vacancy occurs in the office of the public official, for actual services rendered.

REFERRED TO LOCAL GOVERNMENT, JUNE 6, 2023

AN ACT

1 Amending the act of May 1, 1933 (P.L.103, No.69), entitled "An
2 act concerning townships of the second class; and amending,
3 revising, consolidating and changing the law relating
4 thereto," in auditors and accountants, further providing for
5 auditor's compensation.

6 The General Assembly of the Commonwealth of Pennsylvania
7 hereby enacts as follows:

8 Section 1. Section 902(a) of the act of May 1, 1933
9 (P.L.103, No.69), known as The Second Class Township Code, is
10 amended and the section is amended by adding subsections to
11 read:

12 Section 902. Auditor's Compensation.--(a) Each auditor
13 shall receive ten dollars (\$10) for each hour necessarily
14 employed in the duties of the office upon presentation to the
15 board of supervisors of an itemized listing of the dates, times,
16 places and hours worked to perform the audit. No auditor in a
17 township having a population of ten thousand or less is entitled
18 to receive more than [one thousand dollars (\$1,000)] one
19 thousand eight hundred dollars (\$1,800) for completing the

1 annual audit, settlement and adjustment. No auditor in a
2 township having a population in excess of ten thousand is
3 entitled to receive more than [two thousand dollars (\$2,000)]
4 three thousand five hundred dollars (\$3,500) for completing the
5 annual audit, settlement and adjustment.

6 (a.1) The board of supervisors may, by adoption of a
7 resolution, increase the rate of compensation for each auditor
8 under subsection (a) to an amount not greater than eighteen
9 dollars (\$18) for each hour necessarily employed in the duties
10 of the office upon presentation to the board of supervisors of
11 an itemized listing of the dates, times, places and hours worked
12 to perform the audit.

14 (b.1) The board of supervisors may, by adoption of a
15 resolution, increase the rate of compensation for each auditor
16 under subsection (b) to an amount not greater than eighteen
17 dollars (\$18) per hour for not more than fifty hours to audit
18 the accounts of any public official who handles public funds
19 when a vacancy occurs in the office of the public official.

21 Section 2. This act shall take effect immediately.
