RESOLUTION NO. 3-2024

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF FAIRFIELD TOWNSHIP,
ESTABLISHING APPLICATION FORMS AND COSTS FOR REGULATION OF
SOLAR ELECTRIC ENERGY FACILITIES**

WHEREAS, the Board of Supervisors of Fairfield Township has now adopted an Ordinance regulating the construction, operation and decommissioning of Solar Electric Energy Facilities, which, at Sections 5 and 6 thereof, requires the submission of a permit form for any proposed Solar Electric Energy Facility; and

WHEREAS, said Ordinance, at Section 5(B), further calls for the payment of a fee in an amount to be determined from time to time by Resolution of the Board; and

WHEREAS, the Board of Supervisors of Fairfield Township now desires to set forth the required permit form and fee.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Fairfield Township, as follows:

1. An initial flat fee in the amount of \$1,000.00 shall be submitted to the Township along with an application for Solar Electric Energy Facility to cover engineering and legal review of plans and documentation in support of the Facility.
2. The Applicant shall also be billed for any additional costs resulting from additional inspections by any other authorized municipal representative.
3. An application in accordance said Ordinance shall be substantially in the form attached hereto as Exhibit "A".
4. For the building permit required as part of the construction for a Solar Electric Energy Facility, the Applicant shall pay to the Township a fee in the amount of \$5.00, for an estimated cost of \$0.00 to \$1,000.00, and an additional \$1.00 for each additional \$1,000.00 or part thereof.


