WHEREAS, the Township of St. Clair is located at 550 Seward Street,

WHEREAS, the Township of Fairfield is located at 159 Midget Camp
Road, Bolivar, Westmoreland County, Pennsylvania 15923.

WHEREAS, a vacancy exists in the office of tax collector in the Township
of St. Clair.

WHEREAS, the Township of St. Clair desires to enter into an agreement
with the Township of Fairfield, which is an adjoining taxing district for the joint
collection of taxes.

WHEREAS, both Townships agree that Kelly Coursin would be the
individual hired to fill the position of tax collector in the Township of St. Clair
beginning on January 1, 2025 through December 31, 2025. Kelly Coursin being
the current tax collector of the Township of Fairfield and therefore would act as the
joint tax collector for both Townships.

WHEREAS, said tax collector, Kelly Coursin, shall have all the duties of an
acting tax collector in both Townships under the one year term of this agreement
for the purpose and objective of properly collecting taxes in both Townships.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, by the
Fairfield Township Board of Supervisors and the St. Clair Township Board of
Supervisors that Kelly Coursin shall fill the position of joint tax collector for both
Townships beginning on January 1, 2025 through December 31, 2025.
